Mr. Elmhorst nominated Mrs. Teri Hanson for Board Treasurer. Mr. Tesmer closed nominations.

Motion by Mr. Elmhorst, seconded by Mrs. Schmitt to cast a unanimous ballot for Teri Hanson as Board Treasurer. Voice vote – motion carried.

Motion by Mr. Elmhorst, seconded by Mr. Schmidt to approve a 2019-20 budget with \$12,290,399 in anticipated expenses and \$12,232,393 in anticipated revenues. Voice vote – motion carried.

Motion by Mr. Elmhorst, seconded by Mrs. Schmitt to establish a district all property tax levy for 2019-20 at \$3,353,400 with a tax levy mill rate of 9.11. Voice vote – motion carried.

Motion by Mr. Schmidt, seconded by Mr. Elmhorst to approve a 2019-20 fund 10 tax levy of \$2,257,312 and a fund 80 tax levy of \$66,000 and a Fund 38 (non-referendum levy) of \$80,388 and a fund 39 referendum approved tax levy of \$949,700. Voice vote – motion carried.

Motion by Mr. Schmidt, seconded by Mrs. Schmitt to approve Colby Abby Police Department placing a biometric rifle safe and police department rifle at the Colby High School. Voice vote – motion carried.

Motion by Mr. Elmhorst, seconded by Mrs. Schmitt to move the superintendent evaluation to the November meeting to allow additional Board feedback. Voice vote – motion carried.

Motion by Mr. Elmhorst, seconded by Mrs. Schmitt, to adjourn the meeting. Meeting adjourned at 7:05 p.m.
